KUALA LUMPUR, OCT 28 / (BERNAMA) -- THE OLD UMNO WAS DECLARED UNLAWFUL NOT BECAUSE IT HAD UNREGISTERED BRANCHES BUT BECAUSE IT WAS BROUGHT TO COURT, PRIME MINISTER DATUK SERI DR MAHATHIR MOHAMAD SAID TODAY.

STRESSING THIS POINT WHEN OPENING THE PARTY'S GENERAL ASSEMBLY AT THE PUTRA WORLD TRADE CENTRE HERE, HE SAID BEFORE THIS CASE, SOME MEMBERS HAD BROUGHT THE PARTY TO COURT AFTER THE 1984 GENERAL ASSEMBLY BUT LATER DROPPED THE MATTER.

FOLLOWING THIS, THE PARTY HEADQUARTERS CHECKED BRANCH RECORDS AND FOUND THERE WERE 5,000 UNREGISTERED BRANCHES.

AFTER THE BRANCHES WERE REGISTERED, THE PARTY SECRETARY-GENERAL ORDERED THAT THEY HOLD INAUGURAL MEETINGS.

SOME OF THESE BRANCHES HAD BEEN UNREGISTERED SINCE 1966 BUT THIS DID NOT CAUSE THE PARTY TO BE RULED UNLAWFUL. -- MORE
