Chronology of events: Sept 3

3.00am: Traffic police warned car owners to remove their vehicles from both sides of Jalan Damansara, near Anwar's official residence at 47, Jalan Damansara, or risk being summoned or towed away.

9.35: Datuk S. Nallakaruppan produced in court for hearing of his application for him to be transferred from Bukit Aman lock-up, where he is being detained, to Sungai Buloh Prison.

10.00: Barisan Nasional Youth Supreme Council holds meeting at PWTC.

10.20: Nallakaruppan taken away from the court.

10.30: Anwar's aides start removing his belongings from his official residence to his own house at No 8, Jalan Setiamurni 1, Bukit Damansara.

10.35: Manjeet Singh Dhillon, one of Nallakaruppan's lawyers, arrives at Anwar's official residence.

11.05: Manjeet leaves.

11.40: BN Youth chairman Datuk Ahmad Zahid Hamidi calls for Press conference after the Supreme Council meeting at PWTC and reads out a statement pledging loyalty to Prime Minister Datuk Seri Dr Mahathir Mohamad.

11.57: Bernama flashes a note to editors informing them that Anwar has called for a Press conference to be held at his own house.

12.20pm: Ahmad Zahid and his assistant secretary Saifuddin Nasution arrive at Anwar's official residence.

2.10: Court resumes to hear Nallakaruppan's case.

2.25: Three FRU trucks leave from outside Anwar's official residence.

2.40: Ahmad Zahid and Saifuddin leave Anwar's official residence.

3.00: Anwar, leaves his official residence for his own house with wife, Datin Seri Dr Wan Azizah Wan Ismail and children. Anwar stops briefly at the main entrance and tells reporters: "Thank you. It is total fabrication and I'm going to fight it all the way".

3.06: Anwar arrives at his own house in Bukit Damansara.

3.15: High Court judge Justice Abdul Wahab Patail rules that the four affidavits-in-reply filed by the prosecution in the Nallakaruppan's case are relevant to the issues raised. He accepts the affidavits as part of the records.

3.20: Anwar's Press conference begins.

4.25: Court adjourns to tomorrow to hear Nallakaruppan's application.

5.00: Anwar's Press conference ends.

8.30pm: Umno Supreme Council meeting begins at PWTC.

12.32am: Anwar walks out. When approached by reporters, he says he has no statement to make. At the foyer, he addresses the crowd of about 300 people before leaving for home.

1.00: Dr Mahathir announces that the supreme council has unanimously decided to expel Anwar as an Umno member.
