## CUSTOMS ACT 1967

## CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 2) ORDER 2025

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 2) Order 2025**.

(2) This Order comes into operation on 3 March 2025.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in the Schedule, in Part I, by inserting after item 14 and the particulars relating to it the following item and particulars:
