PERINTAH PENGANGKUTAN JALAN (LARANGAN PENGGUNAAN JALAN)
(JALAN PERSEKUTUAN) (NO. 5) 2021 (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 70 Akta Pengangkutan Jalan 1987 [Akta 333], Menteri Kerja Raya membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

(2) Perintah ini mula berkuat kuasa pada 15 Ogos 2025.

ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (PROHIBITION OF USE OF ROAD)
(FEDERAL ROADS) (NO. 5) ORDER 2021 (AMENDMENT) ORDER 2025

IN exercise of the powers conferred by section 70 of the Road Transport Act 1987 [Act 333], the Minister of Works makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Road Transport (Prohibition of Use of Road) (Federal Roads) (No. 5) Order 2021 (Amendment) Order 2025**.

(2) This Order comes into operation on 15 August 2025.

Amendment of Third Schedule

2. The Road Transport (Prohibition of Use of Road) (Federal Roads) (No. 5) Order 2021 [*P.U. (A) 142/2021*] is amended in the Third Schedule by inserting after item 6 the following item:

“7. For public service vehicle.”.
