PERINTAH JALAN PERSEKUTUAN
(LEBUH RAYA PESISIRAN PANTAI BARAT (TAIPING-BANTING)) (PINDAAN) 2019

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Perak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Lebuh Raya Pesisiran Pantai Barat (Taiping-Banting)) (Pindaan) 2019**.

(2) Perintah ini mula berkuat kuasa pada 23 September 2019.

Pindaan perenggan 2

2. Perintah Jalan Persekutuan (Lebuh Raya Pesisiran Pantai Barat (Taiping-Banting)) 2019 [P.U. (A) 150/2019], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 2—

(a) Dengan menggantikan subperenggan (1) dengan subperenggan yang berikut:

“(1) Bahagian jalan yang berikut diisytiharkan sebagai jalan Persekutuan:

(a) bahagian jalan yang dikenali sebagai Lebuh Raya Pesisiran Pantai Barat (Taiping-Banting) yang bermula dari kilometer 143.99 di koordinat U 421777.709, T 333667.462 Grid Bentuk Benar Serong di Tepi (RSO) Geosentrik (GDM 2000) dan berakhir di kilometer 162.07 di koordinat U 438818.638, T 331585.659 Grid RSO Geosentrik (GDM 2000) (kedua-dua jarak diukur dari kilometer 0.0 Lebuh Raya Pesisiran Pantai Barat

(Taiping–Banting) di Persimpangan Bertingkat Banting) termasuk Persimpangan Bertingkat Hutan Melintang, Plaza Tol Masuk/Keluar Hutan Melintang, Plaza Tol Masuk/Keluar Teluk Intan, Persimpangan Bertingkat Teluk Intan dan jalan-jalan sambungannya, iaitu suatu jarak sepanjang 18.08 kilometer; dan

- (b) bahagian jalan yang dikenali sebagai Lebuhraya Pesisiran Pantai Barat (Taiping-Banting) yang bermula dari kilometer 193.59 di koordinat U 455672.836, T 310764.161 Grid Bentuk Benar Serong di Tepi (RSO) Geosentrik (GDM 2000) dan berakhir di kilometer 241.63 di koordinat U 498349.253, T 311975.628 Grid RSO Geosentrik (GDM 2000) (kedua-dua jarak diukur dari kilometer 0.0 Lebuhraya Pesisiran Pantai Barat (Taiping-Banting) di Persimpangan Bertingkat Banting) termasuk Persimpangan Bertingkat Kg. Lekir, Plaza Tol Masuk/Keluar Kg. Lekir, Persimpangan Bertingkat Sitiawan, Plaza Tol Masuk/Keluar Sitiawan, Persimpangan Bertingkat Sitiawan Utara, Plaza Tol Masuk/Keluar Sitiawan Utara, Persimpangan Bertingkat Changkat Chermin, Plaza Tol Masuk/Keluar Changkat Chermin, Persimpangan Bertingkat Beruas, Plaza Tol Masuk/Keluar Beruas dan jalan-jalan sambungannya, iaitu suatu jarak sepanjang 48.04 kilometer.”.

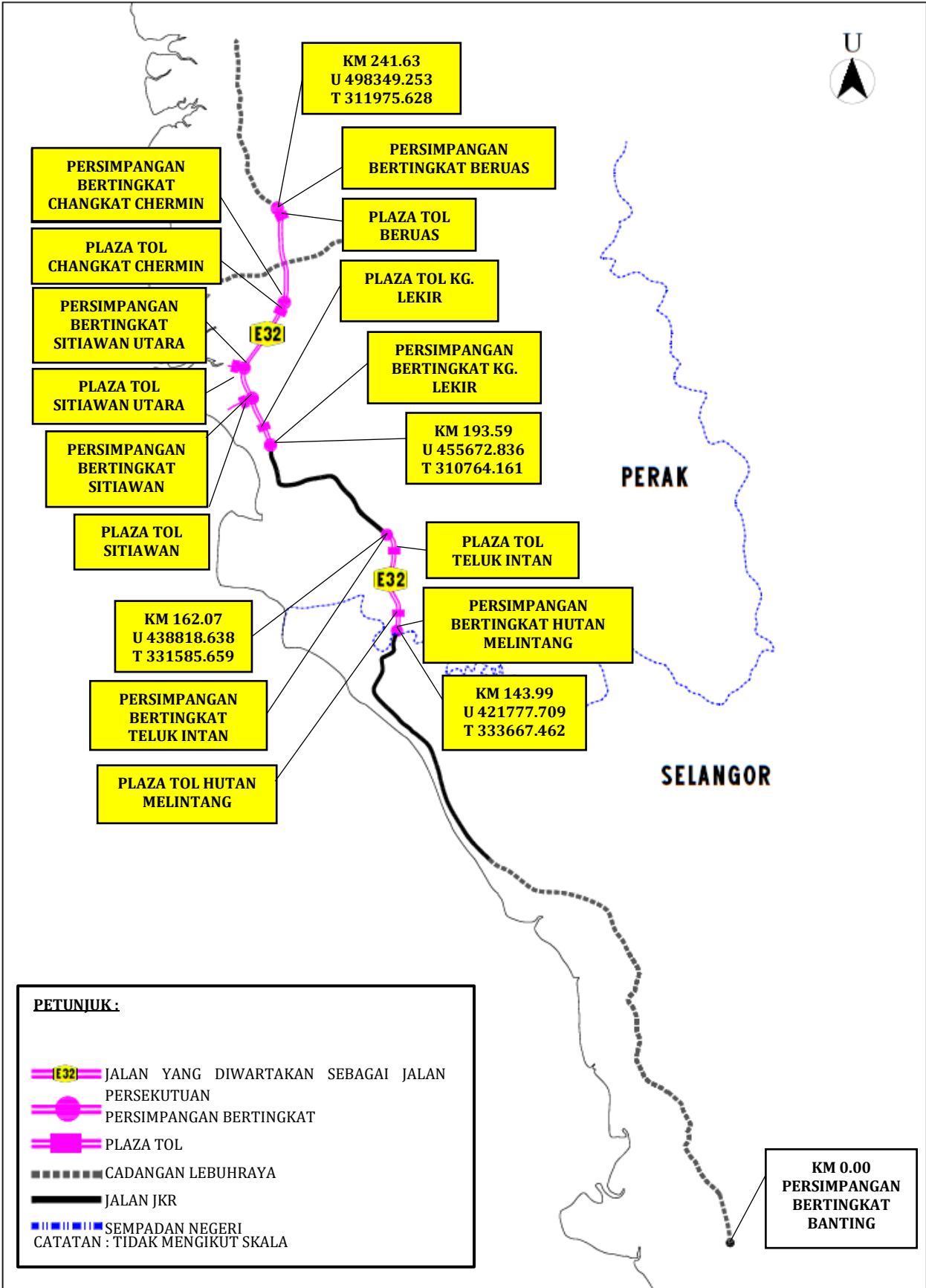
- (b) dalam teks bahasa Inggeris, dengan menggantikan subperenggan (2) dengan subperenggan yang berikut:

“(2) The roads declared to be Federal roads under subparagraph (1) are shown on the map in the Schedule.”.

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST COAST EXPRESSWAY (TAIPING-BANTING))
(AMENDMENT) ORDER 2019

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Perak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Coast Expressway (Taiping-Banting)) (Amendment) Order 2019**.

(2) This Order comes into operation on 23 September 2019.

Amendment of paragraph 2

2. The Federal Roads (West Coast Expressway (Taiping-Banting)) Order 2019 [P.U. (A) 150/2019], which is referred to as the “principal Order” in this Order, is amended in paragraph 2—

(a) by substituting for subparagraph (1) the following subparagraph:

“(1) The following parts of the roads are declared to be Federal roads:

(a) the part of the road known as the West Coast Expressway (Taiping-Banting) commencing from kilometre 143.99 at coordinates N 421777.709, E 333667.462 of the Rectified Skew Orthomorphic (RSO) Geocentric (GDM 2000) Grid and ending at kilometre 162.07 at coordinates N 438818.638, E 331585.659 of the RSO Geocentric (GDM 2000) Grid (both distances are measured from kilometre 0.0 of the West Coast Expressway (Taiping-Banting) at the Banting Interchange) including the Hutan Melintang Interchange, Hutan Melintang Entry/Exit Toll Plaza, Teluk Intan

Entry/Exit Toll Plaza, Teluk Intan Interchange and its link roads, being a distance of 18.08 kilometre; and

(b) the part of the road known as the West Coast Expressway (Taiping-Banting) commencing from kilometre 193.59 at coordinates N 455672.836, E 310764.161 of the Rectified Skew Orthomorphic (RSO) Geocentric (GDM 2000) Grid and ending at kilometre 241.63 at coordinates N 498349.253, E 311975.628 of the RSO Geocentric (GDM 2000) Grid (both distances are measured from kilometre 0.0 of the West Coast Expressway (Taiping-Banting) at the Banting Interchange) including the Kg. Lekir Interchange, Kg. Lekir Entry/Exit Toll Plaza, Sitiawan Interchange, Sitiawan Entry/Exit Toll Plaza, Sitiawan North Interchange, Sitiawan North Entry/Exit Toll Plaza, Changkat Chermin Interchange, Changkat Chermin Entry/Exit Toll Plaza, Beruas Interchange, Beruas Entry/Exit Toll Plaza and its link roads, being a distance of 48.04 kilometre.”.

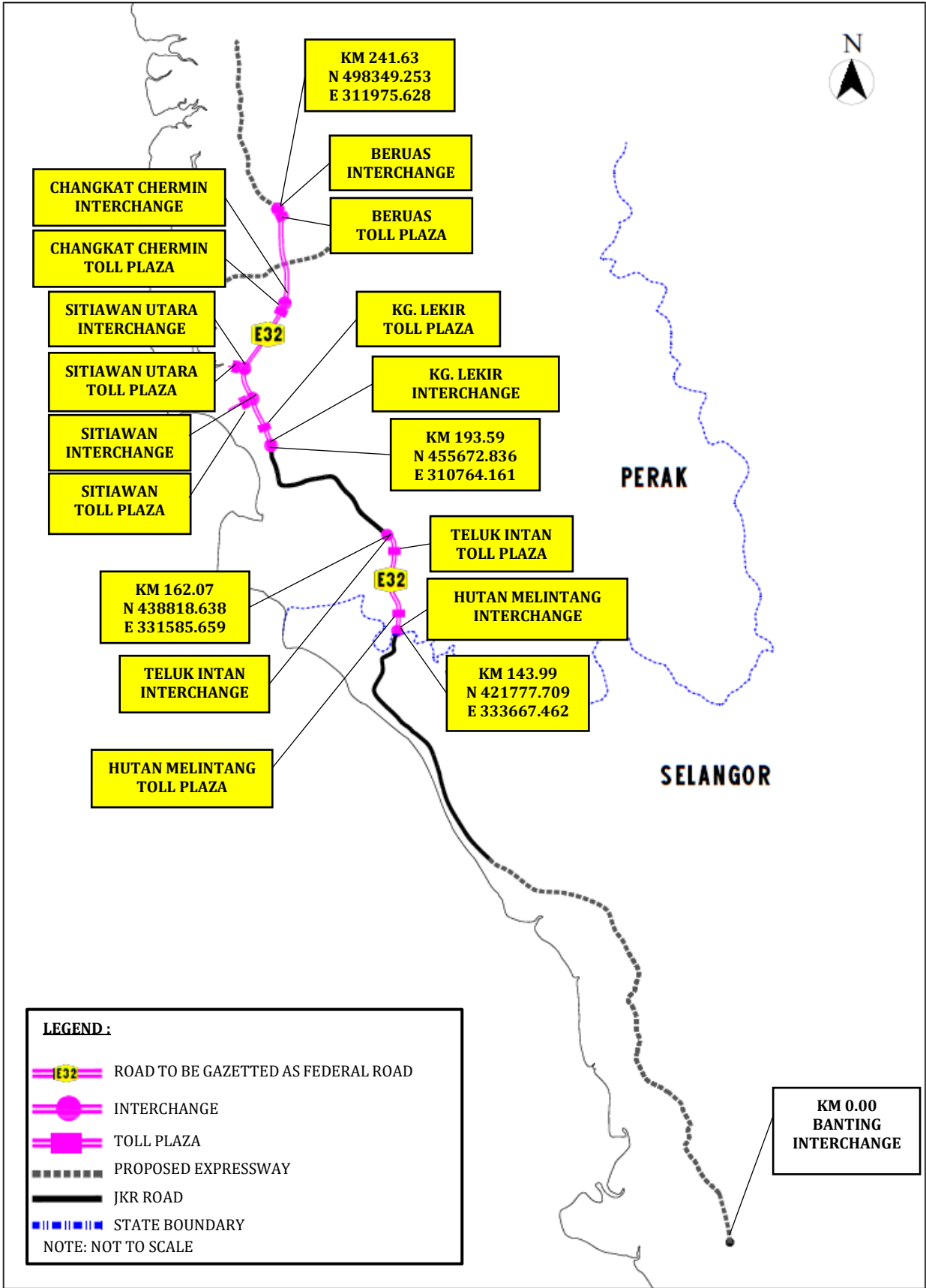
(b) in the English text, by substituting for subparagraph (2) the following subparagraph:

“(2) The roads declared to be Federal roads under subparagraph (1) are shown on the map in the Schedule.”.
