AKTA UBAT (IKLAN DAN PENJUALAN) 1956

PERATURAN-PERATURAN LEMBAGA IKLAN UBAT (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 7 Akta Ubat (Iklan dan Penjualan) 1956 [*Akta 290*], Menteri membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Lembaga Iklan Ubat (Pindaan) 2020**.

Pindaan peraturan 2

2. Peraturan-Peraturan Lembaga Iklan Ubat 1976 [*P.U. (A) 283/1976*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 2 dengan menggantikan subperaturan (1) dengan subperaturan yang berikut:

“(1) Lembaga Iklan Ubat (kemudian daripada ini disebut “Lembaga”) ditubuhkan dan hendaklah terdiri daripada—

(a) anggota *ex officio* seperti yang berikut:

- (i) Ketua Pengarah Kesihatan, Malaysia;
- (ii) Pengarah Kanan Perkhidmatan Farmasi, Kementerian Kesihatan;
- (iii) Pengarah Bahagian Amalan Perubatan, Kementerian Kesihatan;
- (iv) Pengarah Bahagian Penguatkuasaan Farmasi, Kementerian Kesihatan;
- (v) Setiausaha Persatuan Perubatan Malaysia;

- (vi) Setiausaha Persatuan Hospital Swasta Malaysia;
 - (vii) Setiausaha Persekutuan Persatuan Doktor Perubatan Swasta, Malaysia; dan
- (b) anggota yang dilantik oleh Menteri seperti yang berikut:
- (i) seorang doktor pakar perubatan dalam perkhidmatan awam;
 - (ii) seorang ahli farmakologi;
 - (iii) tiga orang ahli farmasi berdaftar dalam perkhidmatan awam;
 - (iv) dua orang ahli farmasi berdaftar bukan dalam perkhidmatan awam; dan
 - (v) seorang pegawai daripada Kementerian yang dipertanggungjawabkan dengan tanggungjawab bagi komunikasi.”.

Pindaan peraturan 7

3. Peraturan 7 Peraturan-Peraturan ibu dipinda–

- (a) dalam subperaturan (1), dengan memasukkan selepas perkataan “nombor satu” perkataan “, dan hendaklah diberikan tarikh tamat tempoh”;
- (b) dalam subperaturan (2), dengan memasukkan selepas perkataan “Nombor siri kelulusan” perkataan “dan tarikh tamat tempoh”; dan

(c) dalam subperaturan (3), dengan memasukkan selepas perkataan “nombor siri kelulusan” perkataan “dan tarikh tamat tempoh”.

Kecualian

4. Pindaan kepada peraturan 7 Peraturan-Peraturan ibu dalam perenggan 3(b) dan (c) Peraturan-Peraturan ini tidak terpakai bagi iklan yang diluluskan sebelum permulaan kuat kuasa Peraturan-Peraturan ini.

MEDICINES (ADVERTISEMENT AND SALE) ACT 1956

MEDICINE ADVERTISEMENTS BOARD (AMENDMENT) REGULATIONS 2020

IN exercise of the powers conferred by section 7 of the Medicines (Advertisement and Sale) Act 1956 [Act 290], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Medicine Advertisements Board (Amendment) Regulations 2020**.

Amendment of regulation 2

2. The Medicine Advertisements Board Regulations 1976 [P.U. (A) 283/1976], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 2 by substituting for subregulation (1) the following subregulation:

“(1) The Medicine Advertisements Board (“hereinafter referred to as the Board”) is established and shall consist of–

(a) *ex officio* members as follows:

- (i) the Director General of Health, Malaysia;
- (ii) the Senior Director of Pharmaceutical Services, Ministry of Health;
- (iii) the Director of Medical Practise Division, Ministry of Health;
- (iv) the Director of Pharmacy Enforcement Division, Ministry of Health;
- (v) the Secretary of Malaysian Medical Association;

- (vi) the Secretary of Association of Private Hospital of Malaysia;
 - (vii) the Secretary of Federation of Private Medical Practitioners Associations, Malaysia; and
- (b) members appointed by the Minister as follows:
- (i) one physician in the public service;
 - (ii) one pharmacologist;
 - (iii) three registered pharmacists in the public service;
 - (iv) two registered pharmacists not in the public service; and
 - (v) one officer from the Ministry charged with the responsibility for communications.”.

Amendment of regulation 7

3. Regulation 7 of the principal Regulations is amended—

- (a) in subregulation (1), by inserting after the words “number one” the words “, and shall be given an expiry date”;
- (b) in subregulation (2), by inserting after the words “The approval serial number” the words “and expiry date”; and
- (c) in subregulation (3), by inserting after the words “approval serial number” the words “and expiry date”.

Savings

4. The amendment to regulation 7 of the principal Regulations in paragraphs 3(b) and (c) of these Regulations shall not apply to advertisements approved before the coming into operation of these Regulations.
