AKTA KEBAJIKAN HAIWAN 2015

PERATURAN-PERATURAN KEBAJIKAN HAIWAN (PEMBANTU SUKARELA KEBAJIKAN HAIWAN) 2020

PADA menjalankan kuasa yang diberikan oleh perenggan 62(2)(m) Akta Kebajikan Haiwan 2015 [Akta 772], Menteri, selepas berunding dengan Lembaga, membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kebajikan Haiwan (Pembantu Sukarela Kebajikan Haiwan) 2020**.

Kelayakan pembantu sukarela kebajikan haiwan

2. Mana-mana orang yang—

(a) berumur lapan belas tahun dan ke atas;

(b) merupakan warganegara Malaysia; dan

(c) merupakan anggota mana-mana pertubuhan bagi kebajikan haiwan yang berdaftar di bawah seksyen 7 Akta Pertubuhan 1966 [Akta 335] dan diperaku oleh pertubuhan itu—

(i) bahawa dia berkelakuan baik; dan

(ii) bahawa dia mempunyai pengalaman sekurang-kurangnya satu tahun dalam pengendalian haiwan,

boleh memohon kepada Lembaga untuk dilantik sebagai pembantu sukarela kebajikan haiwan.

Kad pelantikan pembantu sukarela kebajikan haiwan

3. Lembaga hendaklah mengeluarkan kad pelantikan kepada pembantu sukarela kebajikan haiwan yang dilantik.

Tugas pembantu sukarela kebajikan haiwan

4. (1) Pembantu sukarela kebajikan haiwan hendaklah membantu pegawai kebajikan haiwan untuk menjalankan tugas yang berikut:

- (a) menyediakan latihan, promosi dan program kesedaran kepada pihak yang berkepentingan dan orang awam;
- (b) menjalankan apa-apa program kerajaan yang berhubungan dengan kebajikan haiwan; dan
- (c) menyampaikan apa-apa maklumat yang berhubungan dengan aktiviti yang melibatkan haiwan kepada orang awam.

(2) Pembantu sukarela kebajikan haiwan hendaklah bertindak di bawah kawalan dan arahan pegawai kebajikan haiwan dan hendaklah mempamerkan kad pelantikannya semasa menjalankan tugas.

ANIMAL WELFARE ACT 2015

ANIMAL WELFARE (VOLUNTARY ANIMAL WELFARE ASSISTANT) REGULATIONS 2020

IN exercise of the powers conferred by paragraph 62(2)(m) of the Animal Welfare Act 2015 [Act 772], the Minister, after consulting the Board, makes the following regulations:

Citation

1. These regulations may be cited as the **Animal Welfare (Voluntary Animal Welfare Assistant) Regulations 2020**.

Qualifications of voluntary animal welfare assistant

2. Any person who—

(a) is eighteen years of age and above;

(b) is a citizen of Malaysia; and

(c) is a member of any society for animal welfare registered under section 7 of the Societies Act 1960 [Act 335] and is certified by the society—

(i) that he is of good behaviour; and

(ii) that he has experience of at least one year in the handling of animals,

may apply to the Board to be appointed as a voluntary animal welfare assistant.

Appointment card of voluntary animal welfare assistant

3. The Board shall issue an appointment card to the voluntary animal welfare assistant appointed.

Duties of voluntary animal welfare assistant

4. (1) A voluntary animal welfare assistant shall assist the animal welfare officer to carry out the following duties:

- (a) provide training, promotion and awareness programme to the stakeholders and public;
- (b) carry out any government programme relating to animal welfare; and
- (c) convey any information relating to activities involving animals to the public.

(2) A voluntary animal welfare assistant shall act under the control and direction of an animal welfare officer and shall display his appointment card while carrying out his duties.
