(b) dengan memasukkan selepas butiran 11 butiran yang berikut:

“12. Lembaga Pembiayaan Perumahan Sektor Awam”.

STATUTORY BODIES (DISCIPLINE AND SURCHARGE) ACT 2000

STATUTORY BODIES (DISCIPLINE AND SURCHARGE)
(AMENDMENT OF FIRST SCHEDULE) ORDER 2020

IN exercise of the powers conferred by subsection 23(3) of the Statutory Bodies (Discipline and Surcharge) Act 2000 [*Act 605*], the Prime Minister makes the following order:

Citation

1. This order may be cited as the **Statutory Bodies (Discipline and Surcharge) (Amendment of First Schedule) Order 2020**.

Amendment of First Schedule

2. The First Schedule to the Act is amended—

(a) in item 11, by inserting after the words “Suruhanjaya Pengangkutan Awam Darat” the words “(dissolved *via* the Suruhanjaya Pengangkutan Awam Darat (Dissolution) Act 2018 [*Act 811*])”; and

(b) by inserting after item 11 the following item:

“12. Public Sector Home Financing Board”.
