PERINTAH JALAN-JALAN PERSEKUTUAN (PENGURUSAN PERSENDIRIAN)
(PUNGUTAN TOL) (JAMBATAN PULAU PINANG) (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan Pulau Pinang) (Pindaan) 2020**.

(2) Perintah ini mula berkuat kuasa pada 1 Februari 2020.

Pindaan perenggan 2

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan Pulau Pinang) 1995 [*P.U. (A) 410/1995*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 2(1) dengan menggantikan perkataan “31 Disember 2038” dengan perkataan “31 Disember 2058”.

Penggantian Jadual Kedua

3. Perintah ibu dipinda dengan menggantikan Jadual Kedua dengan Jadual yang berikut:

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(PENANG BRIDGE) (AMENDMENT) ORDER 2020

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Penang Bridge) (Amendment) Order 2020**.

(2) This Order comes into operation on 1 February 2020.

Amendment of paragraph 2

2. The Federal Roads (Private Management) (Collection of Tolls) (Penang Bridge) Order 1995 [*P.U. (A) 410/1995*], which is referred to as the “principle Order” in this Order, is amended in subparagraph 2(1) by substituting for the words “31 December 2038” the words “31 December 2058”.

Substitution of Second Schedule

3. The principal Order is amended by substituting for the Second Schedule the following Schedule:

RATES OF TOLLS FOR THE PERIOD FROM 1 FEBRUARY 2020 TO 31 DECEMBER 2058

2. (a) Motorcycles with sidecars	5.74
(b) Commercial vehicles on three wheels	
(c) Car including station wagons	
3. Vans and buses with two axles and four wheels	9.84
3A. Lorries with two axles and four wheels	12.00
4. Vans and buses with two axles and five or six wheels	20.50
4A. Lorries with two axles and five or six wheels	25.00
5. Buses with three axles	36.90
5A. Lorries with three axles	45.00
6. Vehicles with four axles	60.00
7. Vehicles with five axles or more	75.00

For the purpose of calculating the number of axles and wheels of a vehicle, the axles and wheels of any trailer towed by the vehicle shall be calculated as part of the axles and wheels of the vehicle.”.
