

With GST, the poor will pay more tax

Changeagent: Make no mistake about the 6% GST (Goods and Services Tax) - it is not designed to ease the financial burden on the public. Rather, it is introduced to generate an additional RM30 billion of tax revenue to:

- 1) Reduce the current account deficit which now sits between the 4% and 4.5% range.
- 2) Prevent the country's sovereign rating from being downgraded in the immediate term.

International ratings agency Fitch had just recently downgraded its outlook for Malaysia from "neutral" to "negative".

Foreign investors holding up to 40% of government bonds have issued an ultimatum to Malaysia to reduce its budget deficit to below 4% of GDP or risk an exodus of funds. This would have undesirable effects on the economy as well as cause the ringgit to plunge.

Anyone who suggests that the public will not be burdened by the GST is either an ignorant fool or a very bad liar.

FellowMalaysian: Any new taxes, whether its 6% or otherwise, if applied over a broad spectrum of goods and services as in the case of GST, will deplete the buying power of consumers and the general public.

Finance Minister II Husni Hanadzlah's claim that GST is in fact a progressive tax due to essential goods being exempted from it is therefore a fallacy and stands to be refuted by the opposition parties.

It is also difficult to comprehend how a person earning RM2,000 need only to pay RM15.06 as GST. Such figures do not come across as cogent and in order to convince the people his point of argument, the basis and details of how he arrived at the figures must be revealed for further scrutiny.

SteveOh: What has GST got to do with a consumer's income? GST is a consumption tax and regardless of one's income, one has to pay a flat rate of 6%.

Critics say this is unfair since the poor will pay the same as the rich. Be sure the rate will increase. Income tax reductions that accompany the introduction of GST will benefit the rich who will pay less income tax.

The European countries with fiscal failure all had high GST rates. While GST is meant to decrease the black economy, it will instead result in more fraudulent activity with dishonest businesses collecting GST and pocketing them.

With relatively few paying income tax in Malaysia, it is an incentive for the government to do a tax grab through the GST. It is a convenient blank cheque for the government. To bypass it, do more shopping online.

Look, how do you work out a person earning RM2,000 only has to pay RM15.06 in GST? In the first place, GST is not even income-based but expenditure-based. So how the hell it is related to income?

Second, you did say RM15.06 is 2.6% of this person's expenditure. Working backward and assuming every cent he spends is levied with GST, the amount of expenditure would be about RM579 (just in case you do not know how to work this out and your officers in the Treasury also can't figure this out: it is $15.06/0.026$).

But how do you know each of those earning RM2,000 would be spending only RM579 a month? Minister, I suggest you use your head a bit. Those advising you are not exactly very clever people.

Gazxsw120472: Someone in the *Malaysiakini* forum said that "GST is paid at one level because it only gets sold once". This may not be entirely accurate as it's compounding if you run a business.

A plastic container sold to a nasi lemak seller will have GST included. When the nasi lemak seller sells a packet of nasi lemak using this plastic container, you as a consumer will pay GST on the cost of all the nasi lemak ingredients, labour, transport, etc, plus the nasi lemak container.

This means that the GST is a tax over another tax. The government in this case benefits from taxing a nasi lemak consumer twice.

Mushiro: GST does not depend on how much you earn but on how much you spend. The more you spend the more GST you pay.

So even a poor person must pay more than RM60 in GST for every RM1,000 spent. Items exempted from GST include rice, sugar, salt, dhal, cooking oil, budu, cencalok and basic essentials.

Others ranging from shoes, shirts, dresses, milo, mee, and all necessities, including medicines, will incur GST.

James1067: Indeed, GST is not paid according to your income but purchases made. A motorcycle part if it comes under GST will be expensive by the time it reaches the consumer.

This is just one item which is used as a necessary mode of transport for an average or lower income individual. There are many more items and you can be assured that they will have to fork out more than RM15.
