

Dr M told to rebut ICs claim

KOTA KINABALU: Former Prime Minister Tun Dr Mahathir Mohamad has been urged to rebut the allegation that the extraordinary population increase in Sabah was caused by the deliberate issuance of Malaysian ICs to foreigners based on falsified Statutory Declaration under Project IC or Project Mahathir.

The call was made here yesterday by Opposition Leader and Democratic Action Party (DAP) Advisor Lim Kit Siang, who is also a member of the Parliamentary Select Committee on National Integrity.

He said the allegation made by Parti Bersatu Sabah (PBS) Supreme Council Member Dr Chong Eng Leong at the public integrity hearing at the State Legislative Assembly Building here on Thursday, was a serious one.

Met by reporters here yesterday, Lim noted that those were very serious allegations which Mahathir could not allow to stand in the public domain uncontradicted or unclarified.

He reckoned that alternatively, Mahathir should ask for an appearance

In his submission before the Committee, Dr Chong alleged that the extraordinary population increase in Sabah was caused by the deliberate issuance of Malaysian ICs to foreigners based on false Statutory Declarations.

As a result, there are today around 1.75 million foreigners in Sabah, including those in possession of the Project Mahathir ICs, as compared to 1.5 million genuine locals in Sabah.

He disclosed that in the 1999 certified electoral rolls, through the new IC numbers, it was revealed that there were 150,000 Sabah-born registered voters who were born in 1952 through 1960 but according to the Sabah Statistics Department, the State's population in 1951 was 334,141 and in 1960, 454,421, an increase of 120,000.

He estimated that with 80 per cent registered as voters, there

would only be about 100,000 Sabah-born voters for this period — which would mean that about one-third of voters allegedly born in Sabah in 1952-1960 were foreigners with ICs issued fraudulently with the use of falsified Sijil Akuan under the infamous, dubious foreigners registration scheme popularly known as Project Mahathir False ICs.

Meanwhile, Lim made a surprise visit at a popular fish noodles shop located along Jalan Bundusan in Penampang before he flew back to Kuala Lumpur yesterday.

He was accompanied by DAP KK Branch Chairman Dr Hiew King Cheu and its Sepangar Branch Chairman Frederick Fung.

DAP tells leader to come clean on the 'Project ICs'

KOTA KINABALU: Parliamentary Opposition Leader and DAP MP for Ipoh Timur Lim Kit Siang has called on a senior former government leader to speak up on the serious allegation about "Project ICs" in Sabah which has resulted in foreigners exceeding Sabahans in the State population.

He was responding to a report, on the allegation made by former Senator Dr Chong Eng Leong in his submission to the Parliamentary Select Committee on Integrity at the Sabah State Assembly, Thursday.

"These are very serious allegations which the person cannot allow to stand in the public domain un-contradicted or unclarified. Alternatively, he should ask for an appearance before the Parliamentary Select Committee on Integrity to give his version," he said.

In his submission, Dr Chong alleged that the extraordinary population increase in Sabah was caused by the deliberate issuance of Malaysian ICs to foreigners based on false Statutory Declarations under a so-called "Project IC."

As a result, he claimed there are today around 1.75 million foreigners in Sabah, including those in possession of the Project ICs, as compared to 1.5 million genuine locals in Sabah.
