

NATIONAL TRANSPORT POLICY 2019-2030

FIVE POLICY THRUSTS 23 STRATEGIES

1 STRENGTHEN GOVERNANCE TO CREATE A CONDUCTIVE ENVIRONMENT FOR THE TRANSPORT SECTOR

- Strengthen coordination among agencies and industry players;
- Enhance skills development in the transport sector and make the sector an attractive career option;
- Strengthen and streamline the regulatory framework;
- Embed a robust evidence-based assessment in planning and development of transport sector to meet market demands; and,
- Improve efficiency of clearance process by agencies for logistics.

2 OPTIMISE, BUILD AND MAINTAIN THE USE OF TRANSPORT INFRASTRUCTURE, SERVICES AND NETWORKS TO MAXIMISE EFFICIENCY

- Implement smarter and more efficient use of existing infrastructure and in developing new infrastructure;
- Increase the use of rail service for passengers and goods;
- Upgrade hinterland connectivity to gateways and connect corridors for improved economic distribution;
- Reinforce the maintenance regime of transport infrastructure;
- Enhance competitiveness in air cargo operation to support Malaysia becoming a regional distribution centre; and,
- Modernise integrated logistics to reduce the cost of doing business.

3 ENHANCE SAFETY, INTEGRATION, CONNECTIVITY AND ACCESSIBILITY FOR SEAMLESS JOURNEYS

- Strengthen enforcement to ensure adherence to rules and regulations to improve safety, service quality and reliability;
- Adopt a safe system approach that advocates safer road, rail, maritime and aviation users, infrastructure and vehicle;
- Ensure that Malaysia's transport sector's safety and security are in accordance to international standards; and,
- Strengthen transport infrastructure and intensify the use of digitalisation to enhance connectivity.

4 ADVANCE TOWARDS GREEN TRANSPORT ECOSYSTEM

- Enforce compliance to acts/regulations and shift to international environmental standards;
- Prioritise public transport network as a fundamental structure in charting out sustainable spatial and transportation growth in urbanised areas;
- Accelerate implementation of low carbon mobility initiatives;
- Institute measures to control pollution, noise and waste from the transport sector; and,
- Develop effective communication, education and public awareness (CEPA) to create behavioural change towards sustainable transport.

5 EXPAND GLOBAL FOOTPRINT AND PROMOTE INTERNATIONALISATION OF TRANSPORT SERVICES

- Create an environment that facilitates local transport industry operators to become regional or global players;
- Facilitate regional cooperation and agreements that improve the transport industry; and,
- Ensure transport-related agencies are equipped to support drive in improving Malaysia's ranking in global competitiveness indices.
