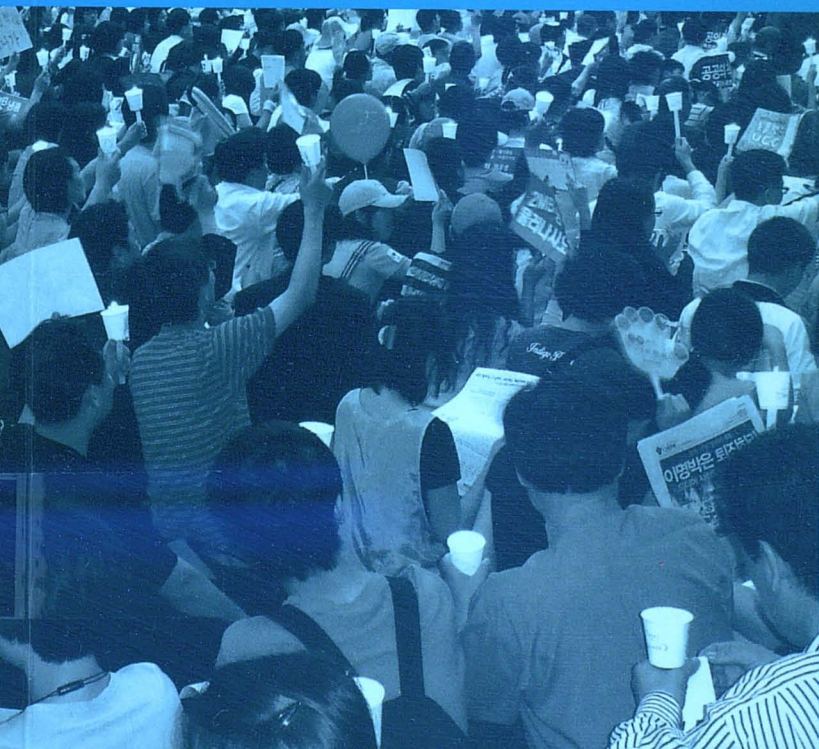

**ADITYA NIGAM** works in the broad field of social and political theory. He is the Joint Director of the Social and Political Theory programme at the Centre for the Study of Developing Societies, India. He has worked on questions of nationalism, identity, secularism, radical politics and Marxism. He has published regularly on these questions in both English and Hindi. He is particularly interested in the contemporary experience of capitalism and globalization in the postcolonial context, its relationship to new experiences of time and urban space, and the ways in which political subjectivities are constituted in the present. He is currently working on a longer term project of looking at a counter-history of capitalism from a post-Marxist perspective. Another aspect of Nigam's interests lies in a fresh engagement with aspects of Indian political and social thought and its relationship to the experience of modernity. Aditya Nigam completed his PhD from the Centre for Political Studies, Jawaharlal Nehru University in 2001 after seventeen years of full time political activism with the communist movement in India. He is author of *The Insurrection of Little Selves: Crisis of Secular-nationalism in India* (Oxford University Press 2006) and *Power and Contestation: India Since 1989* (with Nivedita Menon, Zed Books, London). His next book *After Utopia: Modernity and Socialism in the Postcolony* is in press. Nigam has also been associated with a group of South Asian scholars from Sri Lanka, Pakistan and India, working around the idea of 'the postnational condition'. He has been a Visiting Scholar at the Queen Elizabeth House, Oxford in 1998 and Visiting Fellow at the Shelby Cullom Davis Center for Historical Studies, Princeton University in 2006.
