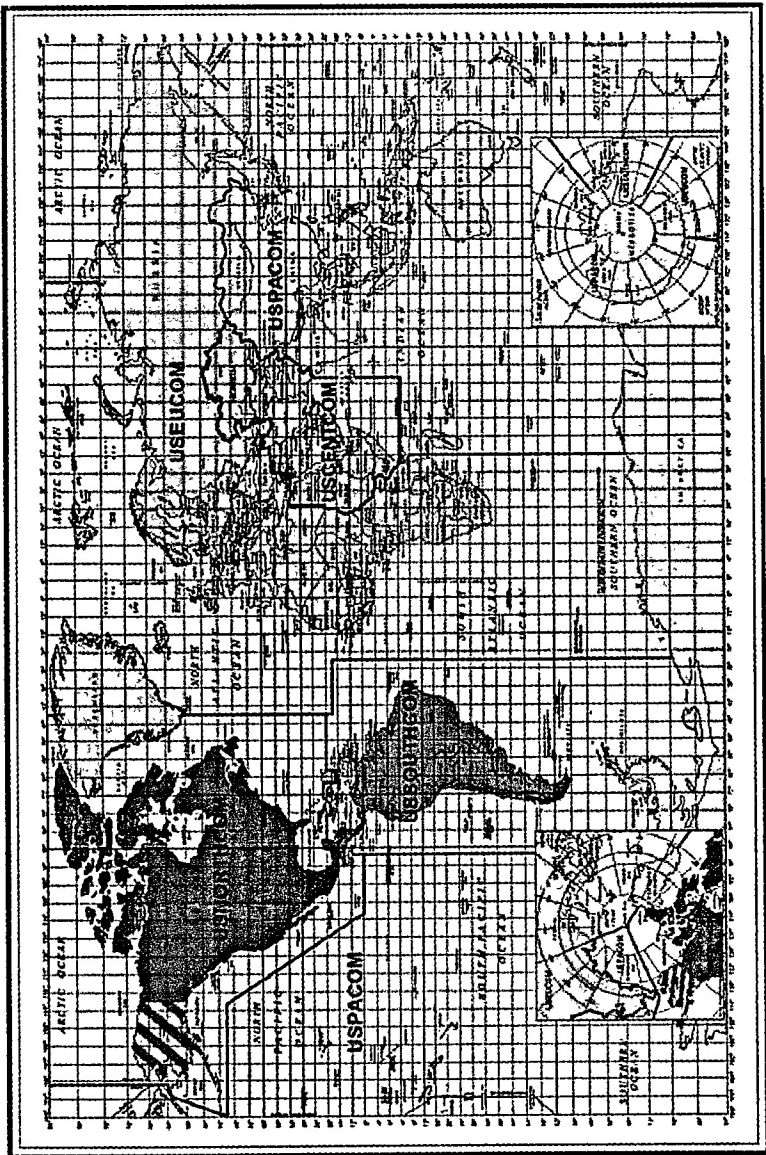

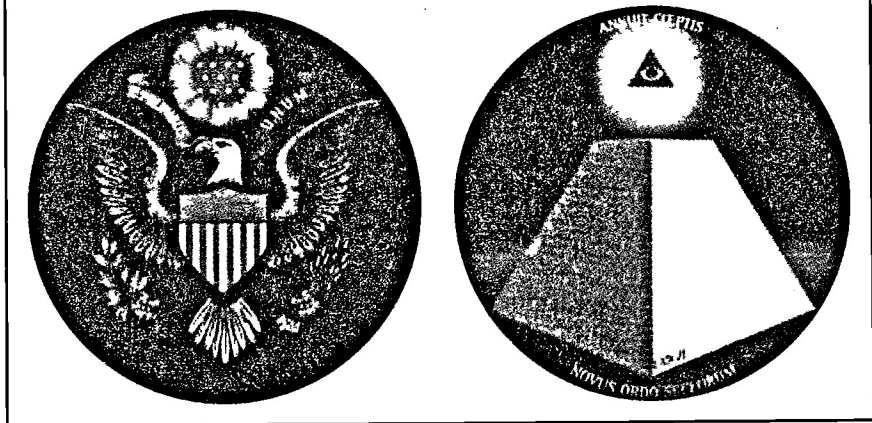
And this, inevitably, brings us to the map on the page facing the copyright notices with the heading *The New World Map of the 21st Century: Towards a World with One Government and Zero Nations*. This map is not a by-product of fertile imaginings, but a precise reproduction of the one created by the US *Unified Command Plan* (UCP).¹ The weird labels on the map in place of country names are the short forms of the five combatant commanders in charge of the world! A colour reproduction of the map with the colour-coded geographical areas is on the front cover.

It is clear that the United States, after having defied the United Nations in invading and occupying Iraq — and having escaped unscathed for its heinous crime — is now establishing itself as the sole authority in the world and plans for global hegemony with the UCP. Without doubt, this shows that the US wants to actualise the Latin mottos on its Great Seal: *E Pluribus Unum* (on the obverse) and *Novus Ordo Seclorum* (on the reverse).

For the benefit of the Latin unlettered, *E Pluribus Unum* means

“From Many, One” and *Novus Ordo Seclorum* means “A New Order of the Ages”. Originally, when Charles Thomson designed the Great Seal in 1782 with these mottos, the words were innocent and had special significance to the newly independent nation: *E Pluribus Unum* was reference to the unification of the thirteen former colonies of the United Kingdom; and *Novus Ordo Seclorum* signified the beginning of the new and independent American Era.

However, the actions and statements of the US in recent times have brought about an enlarged and sinister meaning to these words. The invasion of Iraq, the continued political extortion and intimidation of Iran, the belligerent literature and map of the UCP, and many such similar factors brought out in great detail in this volume clearly show that the Zionist-controlled United States now views its mottos very literally. *E Pluribus Unum* is no longer a reference to the union of former British colonies, but the subjugation and amalgamation of the entire world! Likewise, *Novus Ordo Seclorum* signifies not an independent American Era, but a tyrannical American Dystopia!

Finally, a word in conclusion: the reader is fervently advised not to take any information or views presented in *Future FastForward* at face value. Rather, verify every source annotated before forging conclusions. And when each source is proved true, steel yourself for the imminent nightmare ahead and make preparations for the worst that is now being fast-forwarded.

Introduction

Since the collapse of the Soviet Union, the United States has been depicted as the unchallenged sole superpower. The U.S. boasts of having the world's largest war machine. Her defence budget accounts for about fifty percent of the world's military expenditure, post-Iraq War. Natalie J Goldring, executive director of the program on global security and disarmament at the University of Maryland commented that the \$417 billion for the Department of Defense in 2005 was merely a down payment on the year's military spending.¹ According to Frida Berrigan, a senior research associate at the World Policy Institute's Arms Trade Resource Centre, the U.S. will spend about \$1.5 billion a day or \$17,000 a second on defence in 2005.² To spend stupendous amounts in preparations for, and making, war is confoundingly outrageous when millions live on less than \$2 a day!

The United States is a country nurtured in war. The United States government is a serial war criminal as it has, for the last sixty years, continually violated the Nuremberg Principles, the 1949 Geneva Conventions relating to the protection of civilian prisoners of war, the wounded and sick, and the amended Nuremberg Principles as formulated by the International Law Commission 1950, proscribing war crimes and crimes against humanity. The wanton killing of civilians is dismissed as inevitable, portrayed merely as "collateral damage" by the American mass media.

More importantly, the present power elites have betrayed the

principles enunciated by America's Founding Fathers enshrined in the Declaration of Independence of 1776 and the United States Constitution. They have discarded the wisdom of the leaders of the American Revolution. In 1821, John Quincy Adams, the sixth president of the United States counsels thus:

“Whenever the standard of freedom and independence has been or shall be unfurled, there will her heart, her benedictions and her prayers be. But she goes not abroad, in search of monsters to destroy. She is the well wisher to the freedom and independence of all. She is the champion and vindicator only of her own. She well knows that by once enlisting under other banners than her own, were they even the banners of foreign independence, she would involve herself, beyond the power of extrication, in all the wars of interest and intrigue, of individual avarice, envy, and ambition, which assumes the colours and usurp the standard of freedom... She might become the dictatress of the world; she would no longer be the ruler of her own spirit. Glory is not dominion, but liberty. Her march is the march of the mind. She has a spear and a shield: but the motto upon her shield is Freedom, Independence, Peace. This has been her Declaration: this has been, as far as her necessary intercourse with the rest of mankind would permit, her practice.” (Emphasis added)

A trip down memory lane to the recent past will suffice to fully appreciate the United States Power Elites' insatiable appetite for war and needless destruction, and how they have flouted John Quincy Adam's injunction. Since 1940, the United States has been at war, in one form or another, from CIA-sponsored interventions in South America in support of dictatorial regimes to major engagements in Asia and Africa. On the evening of February 13, 1945, the defenceless German city of Dresden, one of the greatest cultural centres in Europe was reduced to rubble and flames by saturation bombings with “fire bombs” by British and American air force. An estimated one third of the city's inhabitants were massacred, the figures ranging from 300,000 to half a million. These civilians had to pay for the crimes of Adolf Hitler. In August, 1945, the United States dropped atomic bombs on the cities of Hiroshima

and Nagasaki killing an estimated 150,000 and injuring approximately another 130,000. By 1950, another 230,000 died from injuries and radiation. Earlier, fire bomb raids on Tokyo killed 140,000 and injured a million more.⁴ This was truly victor's justice.

On September 7, 1945, General Douglas MacArthur, proclaimed that the forces under his command ***"will today occupy the territory of Korea south of 38th degrees north latitude."*** Thus began the Korean War of 1945-1953. In the period 1958-1965, the United States was complicit in undermining and eventually overthrowing the administration of President Sukarno. Documents at the George Washington University's National Security Archive reveal that information sent by the U.S. Embassy on November, 1965, to General Suharto enabled the Indonesian army to massacre 50 to 100 PKI members every night in East and Central Java. An aerogramme from the US Embassy to Washington on April 15, 1966, admitted that, ***"We frankly do not know whether the real figure for the PKI killed is closer to 100,000 or 1,000,000."***⁵

During the Vietnam War, it has been estimated that more than 3 million Vietnamese were killed, with 300,000 missing in action and presumed dead. The United States lost nearly 59,000 while her allies lost some 6,000. The South Vietnamese army accounted for 225,000 dead. The rationale for this insane war was *the Domino Theory*: that the United States' national security would be endangered by communist domination in Southeast Asia when once Vietnam falls to the communists, and the rest of Southeast Asia follows. SEATO (South-East Asia Treaty Organisation)⁶ was established to counter the perceived threat, and the women of the member states were prostituted in lieu of membership costs, to satisfy the sexual lust of depraved and deprived soldiers on "R & R" (Rest & Recreation) after their tours in Vietnam. Drugs became freely available, brought in by the GIs, and the consequence of which the youths of our societies are still suffering from to this day.

In the war in Afghanistan, the United States Air Force was

dropping the huge GBU-28 bombs, commonly referred to as “bunker buster bombs” to obliterate the likes of Osama bin Laden and his cohorts! GBU-28s (guided bomb units) are 5,000 lb laser-guided bombs armed with BLU-113 warheads. These warheads are the most advanced and powerful “earth penetrating warheads” ever created, and the B61-11 is its nuclear version. UNICEF spokesman Eric Larlock stated, **“As many as 100,000 more children will die in Afghanistan this winter unless food reaches them in sufficient quantities in the next six weeks.”** Recently, in Iraq, we witnessed the immense firepower of the American military in Rumsfeld’s “Shock and Awe” campaign which resulted in the “quick victory”. In a recent report published by the Lancet, it has been estimated that at least 100,000 civilians have died as a result of the war. With a stockpile of over 10,000 nuclear warheads, the United States is also the number one nuclear superpower.

However, I do not share the view of those political pundits who accept uncritically that the United States at the present point in time is at the height of its power, unrivalled in military and economic strength. I cannot but recall the dictum of Mao Tse-Tung:

“All the reputedly powerful reactionaries are merely paper tigers. The reason is that they are divorced from the people. Look! Was not Hitler a paper tiger? Was Hitler not overthrown? U.S. Imperialism has not yet been overthrown and it has the atomic bomb. I believe it also will be overthrown. It, too, is a paper tiger.”

You don’t have to be a commie to come to that conclusion. A very insightful article by Andre Gunder Frank refers to the dollar as **“Uncle Sam’s Paper Tiger Dollar.”**⁸ Despising the United States strategically as a paper tiger does not mean that we can dismiss its awesome military strength tactically. In dealing with the present reactionary U.S. administration, it is crucial that we adopt the correct strategic perspective. For the record, my grievance is not with the American people, for whom I have the utmost respect. The heroic resistance against the Zionist Anglo-American Empire in Iraq has demonstrated conclusively, as in the case of the Vietnam War, that the Empire’s war machine is not invincible, notwithstanding its

overwhelming firepower. The raw pictures of injuries suffered by the U.S. Armed Forces are more gruesome than those from the Vietnam War. If not for advancement in medical science in the treatment of battle injuries, many more would have died. With over 1,500 dead and still counting, close to 25,000 injured (maybe more) and thousands more (some estimate over 30,000) suffering severe mental illnesses, defeat is a foregone conclusion. Just as the Tet Offensive was the critical turning point in the Vietnam War, the Battle for Fallujah has tipped the scale in favour of the anti-occupation forces in Iraq. To conclude otherwise is to wear blinkers and deny the harsh reality.

I anticipate that many will object to the reference that the United States administration is reactionary. But I take comfort that Noam Chomsky, who according to the New York Times is *“arguably the most important intellectual alive”*, refers to the elements in the Reagan-Bush I and Bush II administration as being reactionary and that recent polls indicated that 80% of the respondents in Europe regarded the U.S. as the greatest threat to world peace and that many people in the world increasingly think that President Bush is a greater threat to world peace than President Saddam Hussein, when he was in power.⁹

We must have no illusions as to the predatory nature of the Zionist Anglo-American Empire. It is in its death throes, and as such, will do everything in its power to prolong its survival. Robert Higgs of the Independent Institute in his essay, **“Benefits and Costs of the US Government’s War Making”** warned:

“In matters of war making, as elsewhere in their wielding of power, governments act in the interest of their own leaders, with as many concessions as necessary to retain the support of the coalition of special-interest groups that keeps them in power. Libertarians, of all people, understand that, in Randolph Bourne’s now-hackneyed phrase, ‘war is the health of the state.’ This claim is not some wild-eyed ideological pronouncement; it is as well-established as any historical regularity can be...”

The state of the Zionist Anglo-American Empire has degenerated to such an extent that it warranted Higgs to comment that, **“Congress has become so pusillanimous that it provides no check whatever**

on the president's war-making. In 'authorizing' the president to attack Iraq or not, entirely as he pleased, Congress not only abrogated its clear constitutional duty, but it did so with grotesquely cavalier disregard for the gravity of the matter at stake. It did not even bother to debate the issue, but simply handed over its power to the executive and returned to the workaday plundering that is its only remaining raison d'être. The president and his chief underlings keep telling us that 'we are at war,' but it's just a turn of phrase for public relations purposes, inasmuch as the constitutional requirement of a congressional declaration of war has gone unfulfilled. It provokes no great public outcry, however, so conditioned have the people become to this form of executive usurpation."

Higgs's conclusion on the present state of affairs is both courageous, scathing and frightening: **"Because national security matters lie outside the immediate experience of the great bulk of the citizens, the government can get away with waste, fraud, brutality, and idiocy far more easily in foreign affairs than it can when prescribing student exams, building houses for the poor people, or relieving grandma's aches and pains. The history of U.S. foreign and defense policy in the past sixty years is an unrelieved tale of mendacity, corruption, and criminal blundering. If the government can't fix the potholes in Washington D.C., it certainly can't build a viable liberal democratic state in Iraq. No one of sound mind could have supposed that it would even try, much less that it would succeed. This adventure, like so much else that the government undertakes, is a gigantic hoax, and all too much of it verges on racketeering of the sort described by the legendary U.S. Marine General Smedley Butler."¹⁰**

The purpose of this book is to explain and show why the Zionist Anglo-American Empire is in rapid decline and the inevitable violent and destructive consequences arising thereof. If we can analyse and project the likely future scenarios, we can also make the necessary preparations and take such precautionary measures to mitigate the horrors that will follow from such a meltdown.

There are five propositions that I would like to put before you:

1. The rapid and irreversible decline of the Zionist Anglo-American Empire;
2. The inevitable nuclear wars;
3. Why Israel is the lynchpin to the coming nuclear wars;
4. The end of Empire Capitalism; and
5. By the middle of the 21st century, national borders will be realigned. The 21st century world map will be quite different from what we are accustomed to.

We have already witnessed a major realignment following the collapse of the Soviet Empire, as evident in the countries constituting the “New Europe” and Central Asia. It follows that the world and her borders will not be the same after the demise of the Zionist Anglo-American Empire. The 21st century will be the most violent century in the history of mankind. **The hidden enemy will not go away quietly, that’s for sure.**

But I am also confident that patriotic Americans will rise to the occasion to claim back the United States that gave them the Declaration of Independence and the Constitution (those beacons in man’s quests for freedom and the pursuit of happiness). The true patriots have made too many sacrifices to stand pat and allow the **Zionist Neoconservative Cancer** to overwhelm the body politic. I hold the firm belief that a consequence of the demise of the empire will be a New United States of America, faithful to its Constitution and founding principles, with a new vision and a new mission for a better world; one that is at peace with itself and with the community of nations.

This is not a soothsayer’s book, and I am no fortune-teller nor crystal ball gazer. The evidence in support of my five propositions are in the public domain, some have yet to see the full light of day, but are already accepted as facts by the Imperial Elites of the Zionist Anglo-American shadow governments in the dark corridors of their inner sanctum.

As an attorney and political analyst for 29 years, I cannot afford the luxury of submitting to you for consideration, speculative theories or propositions unsubstantiated by corroborated evidence. “Such an exercise serves no practical purpose, save perhaps as a frivolous intellectual masturbation. Let me assure you that I have no inclination to indulge in such an activity. I intend to submit details and irrefutable evidence in support of my five propositions. Unfortunately the issues

have been distorted by the establishment mass media and wrong conclusions have been drawn. The fog of war has wrought further confusion to the debate. But I am confident that once you have reviewed the evidence contained in this book, you would arrive at the same conclusions as I did.

By far, the majority of the views expressed and the evidence presented on the issues taken up in this book are from the elite of the Zionist Anglo-American Empire and Europe. And although some enlightened U.S. elites have written and spoken out against their own fascist evil empire, they have shied away from confronting the five issues that is being presented in this book. And notwithstanding that a substantial part of the European establishment has opposed the Iraq War and some of the policies of the Zionist Anglo-American Empire, one cannot but be suspicious of their aspirations for the Euro and the re-colonisation of their former colonies. We must be particularly vigilant with regard to the United Kingdom's imperial ambitions emerging from the skirts of the Zionist Anglo-American Empire. If I may borrow a local expression that aptly describes such a threat: ***"A cobra in your trouser pocket."***

One additional point: recently, Donald Rumsfeld, Secretary of Defense of the United States, was quoted as saying, in response to a query from a soldier whether he was aware that scrap heaps in Iraq were cannibalised by soldiers for "hillbilly armour" that was then bolted on to their trucks, ***"you go to war with the army you have, not the army you might want or wish to have at a later time."***¹¹ This doesn't say very much about the often touted superiority and effectiveness of the U.S. war machine. If there is one quote that settles the issue that the U.S. war machine is indeed a paper tiger, this must be it!

How long the U.S. military will put up with the follies of the Zionist Anglo-American Power Elites, only God knows. When the red line has been crossed, those who have sworn to uphold the code of honour will set things right, but my only fear is that it may be too late.

Critics miss the point when they criticise Rumsfeld for being callous and insensitive to the plight of the soldiers exposed to the devastating fire fights with the Iraqi anti-occupation and resistance

forces. There were two messages in that frank and brutal admission. Firstly, to the soldiers, Rumsfeld is saying that given the time constraints of the war agenda, even if he had to arm the soldiers with muskets, and send them to war and to certain death, he would have done so. He had no choice. Secondly, to the segment of the power elite who still did not get the full picture and to the doubting Thomases, he is saying in the plainest language: that you cannot have a war economy, without a war. It's the economics, stupid! And don't forget the problem of peak oil and the coming resource wars.

For those who still hold to the view that President Bush is a moron and the Joker in the pack, I would humbly invite them to have a major rethink. He has been re-elected for a second term, which cannot be said of his father. This is no mean feat. I can appreciate your question: Why would the elites of the Zionist Anglo-American shadow government want Bush, and not Kerry or Howard Dean?

Simple! I am reminded of the famous Nixon quip about Pinochet, ***"He's a bastard, but he's our bastard."*** The Zionist Anglo-American shadow government needed a bastard. President Bush is their bastard who can be trusted to do the dirty work of launching illegal wars, even at the expense of the goodwill and support of major allies and world opinion.¹² When the national security and strategic interests of the United States were threatened externally, the U.S. had Pinochet, the Shah of Iran, Nguyen Van Thieu and the likes of Park Chung Hee and Papa Doc Duvalier as their bastards who did the dirty work of putting down resistance to U.S. hegemony. Now that the United States is about to implode because of antagonistic economic contradictions within the empire and the inherent destructive nature of Empire Capitalism, the shadow government needed a point man who is mean and vicious enough to wield the hatchet. Even though Kerry was a war veteran and a decorated war hero (Purple Hearts, etc.) and vowed to do a better job in kicking Iraqi butts in the recent 2004 election campaign, he was just not dirty, mean and vicious enough. He had a track record of being an antiwar protester on his return from Vietnam. The shadow government cannot afford the risk of having a Commander-in-Chief

to wage ruthless wars at home and abroad that has an antiwar record. Kerry simply did not qualify as their bastard!

There is a poster in the old Wild West: “Wanted – Dead or Alive!” This is an invitation for bounty hunters to hunt down the enemy. President Bush is the perfect fit for the job. But then, need we be really surprised by this choice of the Commander-in-Chief and President?

The history of the United States is replete with such presidents. Let me give you a quick rundown on the various past presidents and how they have been perceived by their peers:

Robert Taft on Harry Truman: ***“It defies all common sense to send that roughneck ward politician back to the White House.”*** President Truman dropped the atomic bomb on Hiroshima and Nagasaki.

Harry Truman on Nixon: ***“He is a no-good lying bastard. He can lie out of both sides of his mouth at the same time, and if he ever caught himself telling the truth, he’d lie just to keep his hand in.”*** President Nixon authorised the illegal war in Cambodia and ordered the “carpet bombing” of Hanoi and Haiphong and other war crimes in Vietnam.

Robert Kennedy on Lyndon Johnson: ***“He tells so many lies that he convinces himself after a while that he’s telling the truth. He just doesn’t recognise truth or falsehood.”*** On being President, he escalated the war in Vietnam and was complicit in allowing Israel to have the nuclear bomb.¹³

Henry Kissinger on Carter: ***“His administration has managed the extraordinary feat of having, at one and the same time, the worst relations with our allies, the worst relations with our adversaries, and the most serious upheavals in the developing world since the end of the Second World War.”*** President Carter gave the directive for secret aid to the Mujahideens to oppose the Soviets in 1979 that gave birth to the Talibans and the Jihadists, the forerunners to Al Qaeda and the bogus War on Terrorism.¹⁴

The United States is in a financial mess. Forget about the exuberance still reflected in the Dow Jones Index. Don't waste your time reading and analysing the employment figures. At the present state of play, it is almost irrelevant. If you are a seasoned poker player or a regular gambler at one of those 5-star casinos in Las Vegas, knowing the odds is second nature and explanations are superfluous. With no alternative but an unprecedented federal deficit, the House planned to vote Thursday to lift the debt ceiling from its current \$7.38 trillion, following Senate passage Wednesday. The government reached the ceiling last month, paying its bill since with cash from the civil service retirement account, which it plans to repay."***

Did you get that? The U.S. government had looted the civil service retirement account! The report continues:

"We are nearing the end of our rope, and it is crucial that Congress act," said Treasury Department spokesman

Nichols. The Republican-led Senate approved the debt limit by 54-44, with only two Democrats and one Republican switching sides. The debate prompted Senator John Kerry, D-Mass., to make his first speech in the Senate since his defeat in the Nov. 2 presidential election. ‘The United States is operating a borrow-and-spend government, continuously stretched by demands for more tax cuts and more spending,’ he said. ‘And when they don’t have the money to pay for their choices, they must put the tab on the national credit card and send the bill to our kids.’

“Not a single Republican spoke during the debate on the debt limit bill, reflecting how politically uncomfortable the measure is for them. That discomfort was highlighted when they refused to bring the bill to a vote before the elections. Completion of the debt limit measure would raise the government’s borrowing limit to \$8.18 trillion. That is \$2.23 trillion higher than when Bush became president in 2001 and more than eight times the debt President Reagan faced when he took office in 1981. Democrats noted that the \$5.6 trillion in surpluses that were projected for the next ten years when Bush took office in 2001 has been transformed into \$2.3 trillion in deficits now estimated for the coming decade. This is the third time since he entered the White House that Bush has gotten Congress to boost the borrowing limit.” (Emphasis added)

2) “ELITE BANKERS NOW PULLING PLUG ON U.S. ECONOMY & CURRENCY”

By former Senator Tim Ferguson — The Ferguson Report

“I have warned for a long time that the Federal Reserve is planning to destroy the U.S. economy by printing the U.S. dollar in exponentially riskier quantities until it blows off the charts and crashes, and by easing credit rates until the average individual and corporate debt loads are so enormous that the resulting massive distortions in the economy suddenly bring on an economic heart attack, leaving no possibility of a short or even medium term recovery. That day is here!

“There is nothing more important in your life right now than the exceedingly dire economic crisis unfolding as I write, and the state of your soul! In other words, if your spiritual house is not in order, the building financial collapse will be so horrible that you will not be able to emotionally or mentally endure it,

and I am addressing the healthy and strong here.”

When was the last time you had your medical check-up? Read on.

“This collapse will knock you out cold, flat on your back, with violence, and most of mankind will never get back up. While the elite are sending signals to their friends that the switch has been thrown, that final preparations for safety are now in order, they are not saying how bad it will be. That is why I began this site. Because I could not find anyone, even doomsayers, who spelled out clearly what is at stake here. I believe that even the elite, such as Sir Templeton, does not fully understand the implications of this crash — that this is the end of America as we know it.” (Emphasis added)

You would have thought that a senator would be considered part of the “elite” but he is not even in the loop. I suppose there are “elites” and elites, such that even Sir Templeton is not part of the inner sanctum. So is the “Empire Economic Meltdown” a fantasy or a reality? Read on.

“That great criminal enterprise — the Federal Reserve — has accomplished step 1, trashing and ending the dollar system, culminating a multi-year, massive, insane inflation of money supply and credit. Some of you might not know who former Senator Tim Ferguson is, especially if you are foreign to American politics. Some might even consider him a maverick and his views and conclusions perhaps exaggerated. I can appreciate your reluctance at this point to come to grips with reality. But what follows will be the knockout blows.

3) RED ALERT — FINANCIAL CRISIS

Rodrigo de Rato, Managing Director of the International Monetary Fund sounded the alarm bells when he said: ***“We believe such a large imbalance of growing indebtedness by the United States is a risk not only for the United States economy, but for the world economy.”***

Laurence Kotlikoff, Economics Chairman, Boston University put the matter in its proper perspective when he said: ***“To give you an idea how big the problem is, you’d have to have an immediate and permanent 78% hike in the Federal Income Tax [to close the \$51 trillion fiscal gap].... The country’s absolutely broke, and both Bush and Kerry are irresponsible in not addressing this problem. This administration and previous administrations have set us up for a major financial crisis on the order of what Argentina experienced a couple of years ago.”*** (Emphasis added)

Richard Russell, Editor-Publisher, Dow Theory Letters, observed: ***“Due to our never-ending deficits, what we’re seeing is a massive transfer of assets from the U.S. to creditors, probably the greatest transfer of assets in history. Over time this is going to mean a lowered standard of living for my kids and your kids, and if it happens quickly it will also mean a lowered standard of living for you and me. When you build up gigantic debts, somebody has to pay for those debts. The great American debt-sponsored party is slowly coming to an end.”*** (Emphasis added)

Martin Wolfe, Associate Editor and Chief Economics Commentator of the Financial Times gave a chilling forecast: ***“The U.S. is now on the comfortable path to ruin. It is being driven along a road of ever rising deficits and debt, both external and fiscal that risk destroying the country’s credit and the global role of its currency.”***

The direction in which the U.S. is heading is assuredly down

and out. Richard Arvedlund, Founder, Cypress Capital Management pessimistically pointed out: ***“...the direction of the dollar is down. The dollar is declining because of our loose money policy, our terrible fiscal deficit and our current account deficit, all of which are heading the wrong way.”***

He is corroborated by Bob McTeer, President of Reserve Bank of Dallas: ***“Over time there is only one direction for the dollar to go — lower.”*** And Jagadeesh Gokhale, Senior Fellow, Cato Institute & research publisher for the Federal Reserve Bank of Cleveland who was equally grim in his assessment: ***“The long-term picture is pretty bad.”*** Paul Volker, the former Chairman, Federal Reserve Board has been quoted as saying: ***“...we have a 75% chance of a crisis within 5 years.”***

How precarious is the situation is best summed up by Bill Gross, Chief Financial Officer of Pimco, the world’s largest bond fund manager when he warned: ***“Too much debt, geopolitical risks and several bubbles have created a very unstable environment which can turn any minute. With all this consumer debt, business debt, government debt, smaller movements in interest rates have a magnified effect. A small movement can tip the boat.”***² The ensuing financial storm and devastation will dwarf even the recent Tsunami in Asia.

The United States is like the stuntman walking on the tight rope over the Niagara Falls. One small slip and he plunges.

Take another perspective, from the outsider’s view. Foreign creditors put up 90% of the approximately \$2 billion a day that is required to ensure that the U.S. does not go into a default. These creditors hold an estimated \$11 trillion or 43% of U.S. privately held national debt, a substantial increase from the 30% since President Bush came to office in 2001. Foreign creditors, the majority of which are central banks, are caught in a dilemma. Either they stand pat and watch the value of their reserves fall drastically or move out of the dollar regime into Euros or a basket of currencies.³ Harvard University President, Larry Summer has dubbed this the ***“balance of financial terror.”***⁴
