Suatu Akta untuk meminda Akta Suruhanjaya Pelabuhan Pulau Pinang 1955.

DIPERBUAT oleh Parlimen Malaysia seperti yang berikut:

Tajuk ringkas dan permulaan kuat kuasa

1. (1) Akta ini bolehlah dinamakan Akta Suruhanjaya Pelabuhan Pulau Pinang (Pindaan) 2004.

(2) Akta ini mula berkuat kuasa pada tarikh yang ditetapkan oleh Menteri melalui pemberitahuan dalam *Warta*.

Seksyen baru 59c

2. Akta Suruhanjaya Pelabuhan Pulau Pinang 1955 [*Akta 140*] dipinda dengan memasukkan selepas seksyen 59B seksyen yang berikut:

"Powers of the Commission to carry on activities which are commercial in nature

59c. The Commission may with the approval of the Minister, carry on all activities, particularly activities which are commercial in nature, as may appear to the Commission to be requisite, advantageous, convenient or beneficial."

HURAIAN

Rang Undang-Undang ini bertujuan untuk meminda Akta Suruhanjaya Pelabuhan Pulau Pinang 1955 ("Akta 140").

2. *Fasal 1* mengandungi tajuk ringkas dan peruntukan tentang permulaan kuat kuasa Akta yang dicadangkan.

3. *Fasal 2* bertujuan untuk memasukkan seksyen baru 59c ke dalam Akta 140 bagi membolehkan Suruhanjaya mempunyai kuasa yang lebih luas terutamanya aktiviti yang berbentuk komersial.

IMPLIKASI KEWANGAN

Rang Undang-Undang ini tidak akan melibatkan Kerajaan dalam apa-apa perbelanjaan wang tambahan.

An Act to amend the Penang Port Commission Act 1955.

ENACTED by the Parliament of Malaysia as follows:

Short title and commencement

1. (1) This Act may be cited as the Penang Port Commission (Amendment) Act 2004.

(2) This Act comes into operation on a date to be appointed by the Minister by notification in the *Gazette*.

New section 59c

2. The Penang Port Commission Act 1955 [*Act 140*] is amended by inserting after section 59B the following section:

"Powers of the Commission to carry on activities which are commercial in nature

59c. The Commission may with the approval of the Minister, carry on all activities, particularly activities which are commercial in nature, as may appear to the Commission to be requisite, advantageous, convenient or beneficial."

EXPLANATORY STATEMENT This Bill seeks to amend the Penang Port Commission Act 1955 ("Act 140").

2. *Clause 1* contains the short title and provision on the commencement of the proposed Act.
3. *Clause 2* seeks to introduce a new section 59c into Act 140 to enable the Commission to have wider powers particularly activities which are commercial in nature.

FINANCIAL IMPLICATIONS

This Bill will not involve the Government in any extra financial expenditure.
